HYNER CLUB MEMBERSHIP REQUIREMENTS:

- 1) Current USHPA member.
- 2) Hold an intermediate (H3/P3) Rating. Novice pilots (H2/P2) may fly only under direct supervision of a qualified observer or instructor.
- 3) A helmet and parachute must be worn at all times when flying.
- 4) Your flight pass must be displayed on your helmet to verify membership to DCNR Rangers.

WAIVER OF LEGAL RIGHTS AND ASSUMPTION OF RISKS:

Note: The term "hang glider" used in this document also refers to and includes any aircraft approved by the Hyner Hang Gliding Club, Inc. membership for use at regulated club flying sites, including, but not limited to, paragliders, and rigid wing aircraft.

- 1) I acknowledge that hang gliding is an active sport and recreational activity involving aviation and that such activity is subject to injury to the participants.
- 2) I will take full responsibility and hold harmless the Hyner Hang Gliding Club, Inc., its officers, USHPA, and the owner or owners property on which I may operate a "hang glider" for any injury that I may suffer or inflict on others or damage I may cause my operation of a "hang glider"
- 3) I further waive and release any and all legal rights that I may be entitled to as a result of any injury I may suffer while flying a "hang glider", as against the Hyner Hang Gliding Club, Inc., its officers, USHPA or the owner or owners of the property upon operate a "hang glider".
- 4) I will not pursue any legal remedies against the Hyner Hang Gliding Club, Inc., its officers or the owner of any property upon which I may be operating a "hang glider".
- 5) I agree to operate any "hang glider" in a safe and responsible manner so as to not endanger the lives of persons or the property of individual.
- 6) **I have read and understand and agree to the above statements. I acknowledge that this document constitutes a waiver of my legal rights. I hereby assume all risks arising out of my operation of a "hang glider".**
